

Application Confirmation Letter

1. The first-year application fee is non-refundable under all circumstances, including visa rejection.

2. I acknowledge that once I have registered for enrolment and obtained a student number, I will be considered a formally enrolled student. Therefore, if the student withdraws for personal reasons after enrolment, all first-year fees as stated in the fee payment schedule will not be refunded.

3. If I am unable to successfully apply for a Malaysian student visa due to failure to pass the EMGS medical examination, the university will provide a refund for specific items. The detailed refund policy is as follows:

<p>Note 1: The university may assist students in applying for a refund of the EMGS visa application fees. However, the actual refund is subject to approval by the Immigration Department. If the refund is returned to the university's account by the Immigration Department, the university will subsequently refund the full amount to the student upon receipt.</p> <p>Note 2: This clause applies only to students who enter Malaysia and complete their medical check-up within one month after enrolment registration. If a student enters Malaysia after one month from enrolment registration and fails the medical check-up, the first-year tuition fees and miscellaneous fees will not be refunded.</p>

4. I acknowledge that students must meet the required language entry requirements before enrolment. If a conditional offer is granted, the student must obtain and submit proof of English proficiency within 10 months of the first academic year.

5. I acknowledge that once I receive the offer letter from Twintech International University College of Technology, the university will only arrange overseas services such as visa processing, airport pickup, and accommodation recommendations after payment has been made to the university's account in accordance with the payment instructions stated in the offer letter.

6. I acknowledge that I must maintain an attendance rate of no less than 85%, and I will bear all consequences resulting from failure to meet this requirement.

8. I acknowledge that, in accordance with Malaysian law, the renewal of a student visa for international students must be processed within Malaysia, and students may only leave Malaysia after the renewal process has been completed. I agree and undertake to remain in Malaysia during the visa renewal process, to provide all required documents, and to fully cooperate with Twintech International University College of Technology in completing the student visa renewal procedures.

9. I acknowledge that during the duration of my study program, I must remain in Malaysia. If I need to return to my home country for research purposes, I may obtain the "International Student Leave Application Form" and the "International Student Leave Request/Departure Notification Form" from Twintech International University College of Technology. I understand that I am responsible for regularly reviewing the overseas study requirements of relevant authorities in my home country (for example, China's Study Abroad Service Center), including the minimum required cumulative days of physical presence in the host country, in order to ensure eligibility for certain certifications or recognition upon return.

10. I acknowledge that, in accordance with Malaysian law, upon completion of my studies, international students must complete the withdrawal process in Malaysia and apply to the Immigration Department for cancellation of the student visa. Only after these procedures are completed may the student leave Malaysia. If a student departs without completing the visa cancellation process, the university is required to report the matter to the police, which may result in an adverse immigration record.

I agree and undertake to communicate with the university regarding my departure plans before purchasing my flight ticket to leave Malaysia, to provide all required documents, and to fully cooperate with Twintech International University College of Technology in completing the withdrawal and student visa cancellation procedures. Please refer to the International Student Management Guidelines for details.

11. I agree and understand that if I am unable to cooperate with the student visa renewal or cancellation procedures, resulting in the failure to complete such procedures, Twintech International University College of Technology reserves the right not to provide any refunds, certificates, transcripts, or letters.

12. I acknowledge that all application documents submitted are true, valid, and authentic. I will bear full responsibility for any consequences arising from the submission of false or fraudulent documents.

13. I acknowledge that if I violate any laws or regulations of Malaysia, the university has the right to terminate my enrolment. I will bear all consequences arising from such actions, and all fees paid will be non-refundable.

14. I acknowledge that I must not conceal any medical conditions that may restrict my entry into Malaysia or my ability to study. I will bear all losses arising from any such concealment, and all fees paid will not be refunded or transferred.

15. I acknowledge that I have received and carefully read the “International Postgraduate Student Handbook” issued by Twintech International University College of Technology (applicable to Master’s and PhD students), or the “Student Handbook of Twintech International University College of Technology” issued by the Student Affairs Department (applicable to undergraduate students). I fully understand that I am required to comply with all rules and regulations stated in the respective handbook. I will bear all consequences arising from any violation of these rules and regulations.

The university reserves the right to make additions, amendments, or revisions at any time in accordance with changes in the study abroad policies of the relevant countries, and to require students to re-sign the agreement to indicate their consent.
